



# BARSNICK RANCH 74

Santa Clara County, 10 Acres

Bluegill, Catfish and Bass

**Property Use Time:** All year (weather permitting)

Recommended for day use only



## DESCRIPTION

This ranch is located in Santa Clara County. The primary use of this ranch will be for fishing. There is a small pond of approximately 1 1/2 acres and will provide bluegill, catfish and bass fishing. Access is excellent for two wheel drive cars and truck. Vehicles with trailers and R.V.'s over 18' in overall length cannot access the property.

## REGULATIONS:

1. Dogs are prohibited.
2. Guns, archery equipment, and shooting of any type is prohibited.
3. Do not disturb the landowner for any reason.
4. Park in designated area only. Do not block road.
5. Open fires and BBQ's are prohibited. Coleman type stoves and gas heated ceramic rock type BBQ's are permitted.
6. Remove all litter from property and pond.
7. Moter bikes, ATV/ATC type vehicles are prohibited.
8. Boats, or float tubes are prohibited.
9. **Daily Fish Bag Limits:** Bass, catch and release only. Catfish, 2 per angler, 5 per family. State Department of Fish and Game limits apply to all other species.
10. Only one pole per angler.
11. W.U. ID stickers must be displayed on vehicles while on property.

## DIRECTIONS:

From Livermore: From Highway 580 and Vasco Road interchange, take the Vasco Road turnoff and head south on Vasco Road until it ends. Turn right on Tesla Road and proceed approximately .8 of a mile. Turn left on Mines Road and go approximately 3.4 miles to where Mines Road turns left (straight ahead will take you to Del Valle Reservoir). Stay on Mines Road and proceed 31 miles to the entrance gate on the right. At 24.6 miles you will see the Sweetwater Firehouse, a bar and store called the San Antone Junction (at this point the road to the left will go to Patterson). Be sure to continue south on Mines Road approximately 6.4 miles to the W.U. gate on the right.



